David Hazel, President, William A. Hazel - After many summers of punch and pipe crews, and several years as Construction Manager for a local developer, David joined William A. Hazel, Inc. full time in 1991. He opened the Fredricksburg Office for the company in 1996 and served as the Branch Manager of that office until 1998. As President of William A. Hazel, Inc., David is responsible for the successful management, direction and profitability of the company. David believes that the company's greatest asset is its employees, and tries to work with each and every one of them.

Jim Mitchell, President, Superior Paving - Jim Mitchell has been the President of Superior Paving Corp. since 2011. He started working at Superior in 1991 after graduating from Lynchburg College with a degree in Business Management. Jim spent the first twenty years of his career focused on growing partnerships with customers and suppliers alike. He served on the board of the HCCA from 1998-2008 including the position of President from 2005-2006. Jim currently serves on the board for the VTCA and is a member of the executive committee for Superior's captive insurance group. He is also in line to be the Chairman of the National Asphalt Pavement Association in 2021.

Bill Tichacek, President, Concrete Pipe & Precast - After graduating from the University of Georgia with a BBA in Marketing, Bill went to work for Martin Marietta Cement in sales. He left MM and moved to Georgia to be a Sales Manager for Atlantic Cement. At Atlantic Cement his responsibilities grew from sales management to a General Manager's role. In 1989 he returned to VA to lead Valley Blox's precast structure business which later was renamed to Americast, Inc. The company acquired VA Precast Corp in Ashland, and expanded into the concrete pipe business by acquiring the Lone Star Ind. pipe plants in Richmond, Chesapeake, and Charleston, SC. In 2012, Americast, Inc. and Hanson Building Products agreed to merge including the assets in MD, VA, WV, NC, SC, and GA and renamed the new joint venture Concrete Pipe and Precast, LLC. Today CP&P operates manufacturing facilities in PA, VA, WV, NC, SC, and GA. Bill has served on the HCCA Board of Directors, American Concrete Pipe Association, and was the first president of the Precast Association of Virginia. He is married and has three children and two grand-children.
