The Heavy Construction Contractors Association seeks to recognize exemplary safety programs, policies, and work records of its member firms. The HCCA Safety Awards are categorized by company operations and separated by total annual man-hours so like-sized companies compete against one another. Trucking Operations are separated by Gross Vehicle Weight and total miles.

RULES OF ENTRY

1. All nominations must be received by the HCCA no later than February 16, 2024.
2. One application per company.
3. Man hours and mileage shall be restricted to and inclusive of all work performed in VA, MD, and DC.
4. Recorded man hours shall NOT include subcontractors.
5. Application must be accompanied by:
 - Statement of Company Safety Policy, signed by Company President
 - Documentation of safety education & training programs
 - Can include manual, awards, newsletters, etc.
 - OSHA 300 Log
 - MSHA 7000-1 (if applying for Category E)
6. HCCA Members may only apply for 2 categories A-E and both trucking categories. Choose the category your firm does the MAJORITY of its annual volume. Enter the letters on page 2 of the application.
