All high quality projects, whether considered 'infrastructure' or beyond, are encouraged to submit.

Note: So member firms of all sizes can compete, the awards committee has established four awards' categories based on the project contract value.

### RULES OF ENTRY

1. All nominations must be received by the HCCA no later than February 11, 2021.
2. Nominations are limited to three entries per Member Company and two per category. The appropriate category must be clearly specified on the nomination submittal form and all accompanying documents
3. The selection of the appropriate category for awards is based on the cost of the work performed by the nominated company.
4. All nominations must be for work performed by members of the HCCA.
5. All nominations shall be limited for work completed between January 1, 2021 and December 31, 2021.
6. Jobs sites must be located in Virginia, the District of Columbia, or Maryland. Directions to and/or a map of the project site must be submitted.
7. A completed HCCA Infrastructure Award Nomination form to propose your project must accompany each entry.
8. Photos should be submitted in PDF or PowerPoint format, titled with project name and category.
9. Following submission, the committee will schedule a ~10 minute conference call in which the nominating person will further explain their photos, PowerPoint, and/or documentation to the committee.
10. We encourage winners to invite owners, subcontractors, suppliers, inspectors and any other critical roles on the project to the awards ceremony.
